What a year! We have each dedicated many years of our lives to the Planned Parenthood movement and this has been one of the most challenging and inspiring. Planned Parenthood in Texas, Louisiana, and across the nation has been under continual political attack. And through it all we have never relented in our commitment to ensure that women and men are able to access the health care and information they need and deserve.

When we look back at this fiscal year, the Texas legislative session and the two special sessions that followed it are stand out events. After years of witnessing the legislature slash funding for women's health care and systematically dismantling the health care network in Texas, thousands joined with us and said — "Enough is enough!"

Texans from all over camped out in the Capitol for the citizens' filibuster to speak out for women's health. Thousands filled the Capitol rotunda and tens of thousands witnessed history when Senator Wendy Davis filibustered House Bill 2 (HB2), the draconian bill that would virtually eliminate access to safe, legal abortion in Texas.

That terrible bill lit a fuse here in Texas and sparked a growing movement. Texans showed their support at rallies here in Houston and across the state, culminating in a sea of orange "Stand with Texas Women" t-shirts blanketing the steps of the Capitol in Austin on a hot July day.

It was truly inspiring to see the thousands of people who turned out, the enormous outpouring of support, and the sheer ENERGY and WILL to do something to fight back against these outrageous attacks on women's health and women's rights.

We experienced some terrible lows this year when we were forced to close our health centers in Bryan, Lufkin and Huntsville. After years of funding cuts, thousands of low income women in rural parts of Texas lost access to vital health care. Tragically, women in the Brazos Valley not only lost their trusted family planning provider, they also lost access to safe and legal abortion because of the passage of Texas HB2.

These laws have absolutely nothing to do with women's health or safety and were drafted with the solitary goal of shutting down health centers. And that is exactly why we are committed to fighting them. An individual's access to health care should not depend on his or her zip code.

It's a travesty what politicians are trying to do to women's health care. We're so grateful that all of our supporters recognize this and continue to stand up, speak up and support Planned Parenthood's mission and the thousands of patients who rely on our health centers to stay healthy.

Despite the many challenges we've faced this year, we have made some great strides. In New Orleans, we are close to reaching our Capital Campaign goal and hope to open our new health center there in the early months of 2015. We relocated and updated two of our Houston area health centers, we began accepting commercial health insurance and building the infrastructure we need to be ready for the implementation of the Affordable Care Act, and we celebrated the 25th Anniversary of our HIV Program here at PPGC.

Thanks to your generous support, last fiscal year we raised over \$5.7 million making it possible for thousands of women, men and teens, across Houston, southeast Texas and Louisiana to access the health care services and education they need and deserve.

Your continued commitment to stand with us makes you an essential part of this movement. Together we are making certain that Planned Parenthood will always be here. On behalf of our clients and staff—thank you for standing with us!




MISSION





Total: 87,900




Last year, more than 10,000 Louisiana women and men received care at our Baton Rouge and New Orleans health centers. And more than 43,000 women and men received care at our 10 health centers across Houston and Southeast Texas.

In 2013, our 12 health centers in southeast Texas and Louisiana provided the following services to help individuals stay healthy:


87,900 health care visits provided for women, men and teens (family planning, HIV and dysplasia visits)

- 53,797 unduplicated clients served: 46,563 women | 7,234 men | 2,481 teens
- 9,780 Pap tests performed
- 14,417 Well woman exams
- 13,600 estimated unintended pregnancies averted through birth control
- 87,553 tests for sexually transmitted infections
- 18,975 HIV prevention counseling and testing visits provided
- 1,052 women received care for precancerous cervical conditions


PATIENT DEMOGRAPHICS (TX & LA)




PAYMENT FOR SERVICES (TX & LA)

Planned Parenthood Gulf Coast began accepting commercial health insurance in April of 2013 and is currently contracted with several major insurance companies including Aetna TX, Blue Cross Blue Shield TX & LA, Cigna, and Humana.

"It's about affordability, accessibility and affability," says Donna Alexander, Senior Vice President of Program Services. "We are aiming to be the provider of choice in the Gulf Coast Region. We care deeply about our patients and take the time to discuss their options with them so that they can make their own informed decision about their health," says Donna. Planned Parenthood Gulf Coast exceeds 2013 fundraising goal by nearly \$1.2 million!

Thanks to loyal supporters who once again demonstrated their unwavering compassion and dedication to our patients through their charitable giving, Planned Parenthood Gulf Coast received more than \$5.7 million in philanthropic support in its 2013 fiscal year (September 1, 2012 - August 31, 2013). That total includes a \$2 million transformational grant from Houston Endowment toward the *Next Leap Forward* campaign.

Planned Parenthood Gulf Coast was also the recipient of a \$250,000 matching gift in December 2013 from an anonymous donor to fund the *Next Leap Forward* and the relocation and upgrade of the Greenspoint Health Center! Charitable gifts help to ensure that Planned Parenthood Gulf Coast can continue providing the high-quality, affordable health care that our patients need and deserve.

Planned Parenthood Gulf Coast Continues to Excel in Educating the Community!

The Education Department at Planned Parenthood Gulf Coast has been educating the community on teen pregnancy, prevention and other sexual health and reproductive issues for years. The department has implemented several new programs including an evidence-based course of study for incarcerated youth, a pregnancy education program for expectant mothers in New Orleans, and the PPGC Training Center, which provides professional training courses on reproductive and sexual health for counselors, nurses, teachers and community health workers.
