



**Mission**

The mission of Planned Parenthood of Hawaii (PPH) is to be the leading provider of reproductive health services, education and advocacy for the people of Hawaii.

**Health Services**

Planned Parenthood of Hawaii works to prevent unintended pregnancy and is committed to making every child a planned and wanted child. We believe that decisions about childbearing should be made by women who are encouraged to involve their families and doctors. PPH provides accurate reproductive health information and access to affordable services to help sexually active adults and youth be safe from unwanted pregnancies, from sexually transmitted infections and from sexual coercion.

More than 7,500 individual patients received approximately 12,000 separate visits in PPH health centers during fiscal year 2009. PPH reproductive health care services include annual pelvic and clinical breast exams, Pap smears and colposcopy screening for cervical / reproductive cancers, and treatment for abnormal cervical cells.

- Family planning services: affordable and broad choice of FDA-approved contraceptives, birth control supplies and Emergency Contraception (morning after pill).
- Reproductive health care, education, counseling and birth control services (as requested) for adolescents, age 14 and older.
- Pregnancy testing and options counseling.
- Teen counseling including encouraging teens to involve their parents, how to resist sexual coercion, safer sex and use of abstinence as a method of birth control.
- Risk assessments: including risks for intimate partner violence, depression, alcohol & drug abuse, obesity, eating disorders.
- Screening and treatment for sexually transmitted infections.
- Services for women approaching and experiencing menopause.
- Vaccinations for Human Papilloma Virus (HPV) (to prevent some types of cervical cancer).

PPH accepts most Hawaii employer-sponsored and public health insurance plans. We accommodate uninsured patients by offering a sliding fee scale based on income for a same day / cash pay discount.

PPH offers both medication and surgical abortion services and support. Medication abortion (by pills) up to 9 weeks. Surgical abortion services up to 16 weeks. PPH offers abortions outside of a hospital setting at a substantially lower cost.

Visited in April by a Planned Parenthood Federation of America (PPFA) Affiliate Accreditation site team that conducted a rigorous review of programs, protocols and systems, PPH was awarded Full Accreditation that spans the next four years. The site visit team stated, "The care delivered at the PPH health centers is excellent and the affiliate is to be commended for the complexity of services offered."

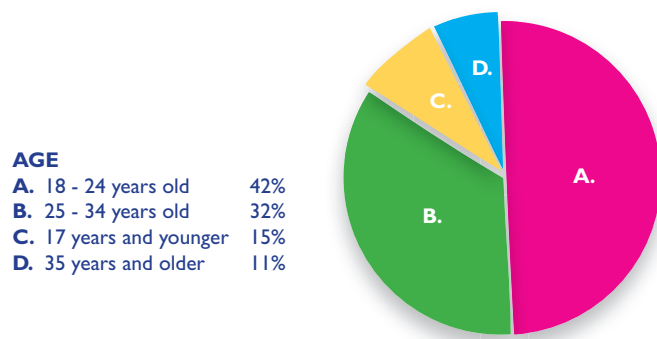

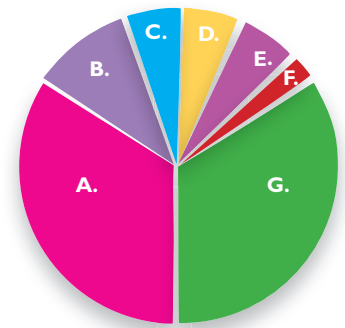
## Planned Parenthood of Hawaii Patients

66% of all PPH patients have family income at or below the federal poverty level (\$25,360 for a family of four in FY 2009). 90% of all PPH patients have income at or below 250% of the poverty line and may be considered low to moderate income.

## Educational Programs

The PPH Education and Training Department provides medically accurate reproductive health education that includes science-based programs, in public and private school settings, universities, community groups and faith-based organizations. In 2009, for the first time, PPH had an active full-time educator on the Big Island of Hawaii. During the year, four full-time PPH educators presented 880 separate educational sessions and made 23,730 direct educational and outreach contacts, reaching more than 4,500 students, parents, teachers, youth-serving professionals and other interested individuals across the state of Hawaii. PPH educators were active in 33 schools on Oahu, Kauai and the Big Island. PPH continued presenting the multi-week Making Proud Choices (MPC) curriculum at Ilima Intermediate School and Washington Middle School during the 2008/2009 school year. Identified by the Centers for Disease Control as “a program that works,” the MPC curriculum teaches youth to make healthy and responsible choices for their futures, for their families and for their communities. PPH educators also provide training to other health care providers, educators and youth service workers on various topics of reproductive and sexual health. PPH educators are recognized for their knowledge and proficiency and their willingness to collaborate with other organizations and groups.

## Advocacy

PPH advocates for and supports public policies that guarantee an individual’s rights to privacy; choice over one’s own fertility; access to affordable, high-quality reproductive health care; and the availability of medically accurate health and sexuality education. During the 2009 legislative session, PPH introduced and secured passage of SB777 Relating to Comprehensive Sex Education. This bill requires that any recipient of state funding intended for sexual education provide comprehensive and medically accurate education, including information about contraception and sexually transmitted disease. When Governor Lingle vetoed it at the very end of the session, PPH and our partners worked with the Legislature to override the veto. All Anti-Choice bills were defeated in the 2009 legislative session. With support from important committee chairs, six bills that sought to restrict access to abortion and to criminalize abortion were never heard.

## Source and Use of Funding

Planned Parenthood of Hawaii relies on the support of individual donations, grants and the revenue generated by fee-paying patients to provide low- or no-cost services to individuals who have no other resources to pay for reproductive health care. PPH educational programs are funded primarily from donated revenue. During fiscal year 2009, Planned Parenthood of Hawaii’s revenue was \$3,328,970.
