A Message from Linda Williams: On Commemorating *Roe*

As we commemorate the 36th anniversary of *Roe v. Wade*, we have a pro-choice president, *Roe* is safe, and we can all kick back and relax for four years, right?

Wrong, wrong, wrong, wrong, of course. We grow complacent at our very great peril.

Some of you may share my memories of the Clinton administration. What happened after twelve years of anti-choice presidencies that eroded access to abortion and contraception? On day two, President Clinton reversed the yet-to-be-enforced domestic gag rule which prohibited any organization receiving U.S. government funding from using its own money to provide, refer for or advocate abortion. He appointed two pro-choice Supreme Court justices—Justice Ginsburg in 1993 and Justice Breyer in 1994. He vetoed anti-choice legislation when the Congress changed hands in 1994. That was pretty much it.

Very little ground was reclaimed for women's health. Title X, the federal family planning program, was never officially reauthorized because the topic of contraception was considered too controversial in the Congress. Women in the military didn't gain access to abortion. A plethora of anti-choice laws and regulations from the Reagan and first Bush years remained in place. States continued to enact ever more restrictive barriers to access with the blessing of the Supreme Court.

We need to do better this time. The damage is far greater and in some cases more insidious. Access to contraception and abortion has been severely limited for young, poor and rural women by a host of quiet administrative actions and obscure insertions in giant legislative packages as well as more overt and high profile laws, regulations and court cases. State laws throughout the country impose additional barriers and are routinely approved by the courts.

The federal court system from bottom to top has been systematically populated with anti-choice ideologues. Five of the nine U. S. Supreme Court justices are eager to uphold state laws that further erode the protections given women by *Roe*. Four are on record as wanting to overturn it outright.

Remember that *Roe v. Wade*, relentlessly attacked from the moment the decision came down, has been almost as steadily eroded. For twenty of the past twenty-eight years, we've had anti-choice presidents, frequently working in concert with an anti-choice Congress. Now we have a window of opportunity—just four years that we can count on—to reverse the damage and secure advances in access to reproductive health. It won't be automatic, it won't be easy, and success is by no means guaranteed.

Many people aren't aware that neither House of Congress has a majority of pro-choice members. At least one key committee chair in the House is strongly and outspokenly anti-choice; he routinely blocked any legislation which contained provisions that strengthened access to contraception in the last session. The Senate Majority leader supports family planning but opposes abortion. And we are not the only constituency clamoring for redress of wrongs.

To overcome these formidable barriers, our voices must be clear, strong and persistent. We will need to cut through the clamor to be heard at the White House so our new president will make our issues a priority with Congressional leaders during his honeymoon period. We must secure a commitment from the Speaker to contain the hostile committee chair, and we must vigorously and vocally support and reward our champions in the Congress who carry legislation and work forcefully on our behalf.

Key provisions of the current recovery packages in both the House and the Senate expand access to contraception for poor women. Our first step is to strongly encourage our legislators to support those provisions. One of our next must be to ensure access to contraception and abortion is included in any health care reform package. We must advocate persistently to increase federal family planning funds, include all pregnancy-related services in Medicaid, eliminate funding for failed abstinence-only sexuality education, and reverse a myriad of destructive administrative policies and regulations. We must overtly support the nomination of pro-choice judges and justices to all levels of the federal courts, and we must consistently make ourselves heard above the inevitable anti-choice uproar.

Economic Impact on PPMM

Every day we read or hear about elected officials debating what to do regarding the economic crisis facing California and the rest of the country. Draconian cuts to health care, education, and prevention services are daily headlines along with record unemployment and home foreclosure rates.

At Planned Parenthood Mar Monte (PPMM) our health centers are seeing an unprecedented increase in demand for services as people lose health insurance, can't afford co-payments, or because other health safety-net providers close their doors due to shrinking reimbursement rates and delays in payment. In December alone, 9,000 additional people sought our reproductive and general health services, a 21% increase from December 2007.

As policy advocates for our clients, we are often asked by policy makers, "why should family planning be protected when other taxpayer supported services are equally important?" Tough economic times demand we use a sensible fiscal approach to the delivery of services. UCSF research shows that every dollar California spends on family planning services saves an estimated \$2.76 in medical and social services costs in the year of expenditure and \$5.33 in the succeeding five years. In addition, each dollar spent costs the state just 10 cents; the state receives 90 cents from the federal government through a federal match.

At PPMM we provide health care to some of the poorest families in the country. A 2008 publication, *The Measure of America*, ranked the 20th Congressional District (CD) in the San Joaquin Valley dead last in the United States for quality of life with only half of the households posting annual incomes above \$16,767. Appalachia, an area synonymous with poverty fared better. Voluntary family planning services provided by PPMM are critical to helping families in that region and other areas of the affiliate begin the climb out of poverty.

Any additional cuts to teen pregnancy prevention programs coupled with less access to family planning services will prove costly to Californians in the years to come. Nine of the top ten counties in the state for teen births fall within PPMM's service area, and not surprisingly, seven are in San Joaquin Valley. In 2008 the Public Health Institute reported "the substantial economic costs to society associated with teen births cannot be ignored," as California's declining teen birthrate came to a halt. Nevada ranks 7th highest in teen birth rates in the country, and teen births cost Nevadans \$67 million. Teen births cost California \$1.7 billion dollars; the state ranks 26th in teen birth rates and highest in sheer numbers of teens giving birth, with 562,440 teens births annually.

Both Nevada and California cannot afford to cut back on family planning and teen pregnancy prevention services during tough economic times, and neither can Planned Parenthood Mar Monte. As more individuals depend on us for services we will be counting on you, our supporters, to work with us to fulfill our mission to ensure that every individual has the knowledge, opportunity and freedom to make every child a wanted child, and every family a healthy family.

The agenda prioritizes affordability, accessibility, quality of care, comprehensive health care coverage, and culturally and linguistically appropriate services. We will continue to work with those who can influence public policy to reflect the needed changes. And regardless of policies we will continue to meet the needs of our patients, providing them with quality care.

January is Cervical Cancer Awareness Month

Cervical Cancer afflicts nearly 12,000 women annually according to the Center for Disease Control. Human Papilloma Virus (HPV) is the most widespread STD in the United States, and certain strains of HPV cause cervical cancer. Six in ten women who contract cervical cancer either never had a Pap Smear or put it off for more than five years. Planned Parenthood provides quality cancer screening and offers the HPV vaccine.
