WHAT IS A PLANNED PARENTHOOD OF MARYLAND GIFT ANNUITY?

A Charitable Gift Annuity is a special giving arrangement in which, in return for a gift of \$10,000 or more (\$20,000 for two annuitants), Planned Parenthood of Maryland provides guaranteed, fixed payments for the rest of your life. After your lifetime, the remainder of your gift will support the work of Planned Parenthood of Maryland.

In addition to guaranteed annuity payments for life, a Planned Parenthood of Maryland Gift Annuity has many other advantages:

Advantages to you:

- A Planned Parenthood of Maryland Gift Annuity often will increase your income.
- You receive a tax deduction because part of your annuity principal is considered a gift to Planned Parenthood of Maryland.
- Part of the payment you receive from your annuity is not subject to federal, state or local taxes.
- If you fund your annuity with appreciated securities, you will avoid a part of the capital gains tax on appreciation in value.

Please be assured that Planned Parenthood of Maryland provides each donor with a contract that affirms the obligation to provide fixed payments for life. We place all charitable gift annuity donations in distinct accounts at TIAA-CREF Company, FSB. Planned Parenthood is required by several states, including New York and California, to maintain an adequate reserve fund that will meet all future obligations and to invest those funds prudently. In maintaining our program, we guarantee that if ever these resources were insufficient, the general assets of Planned Parenthood Federation of America would be used to meet charitable gift annuity payments.
