Our Commitment To Privacy

Your privacy is important to us. To better protect your privacy we provide this notice explaining our online information practices and the choices you can make about the way your information is collected and used. To make this notice easy to find, we make it available on our homepage and at every point where personally identifiable information may be requested.

The Information We Collect

This notice applies to all information collected or submitted on the Planned Parenthood Association of Hidalgo County, Texas, Inc. website. On some pages, you can order products, make requests and register to receive materials. The types of personal information collected at these pages are:

- Name
- Address
- Email Address
- Phone Number
- Credit/Debit Card Information

On some pages, you can submit information about other people. For example, if you sign up for the Planned Parenthood Action Network (PPAN) you can also submit other people's contact information such as their email to be sent a similar email alert. In this circumstance, the types of personal information collected are:

- Name
- Address
- Phone Number
- Email

The Way We Use Information

We use the information you provide about yourself when signing up for the Planned Parenthood Action Network or (PPAN), only for that sole purpose. We do not share this information with outside parties.

We use return email addresses to answer the email we receive. Such addresses are not used for any other purpose and are not shared with outside parties.

You can register with our website to join our donor mailing lists or PPAN email lists. Registering for donations or to the PPAN lists can be done by emailing us directly to plannedparenthoodhidalgo@gmail.com. Information you submit to our website will not be shared with outside parties.

Finally, we never use or share the personally identifiable information provided to us online in ways unrelated to the ones described above without also providing you an opportunity to opt-out or otherwise prohibit such unrelated uses.

Our Commitment to Data Security

To prevent unauthorized access, maintain data accuracy and ensure the correct use of information, we have put in place appropriate physical, electronic and managerial procedures to safeguard and secure the information we collect online.

Our Commitment to Children's Privacy

Protecting the privacy of the very young is especially important to us. For that reason, we never collect or maintain information at our website from those we actually know are under 13, and no part of our website is structured to attract anyone under 13.

How You Can Access Or Correct Your Information
