More than 1,100 men, women and youth received medically accurate sexual health education in 2007.

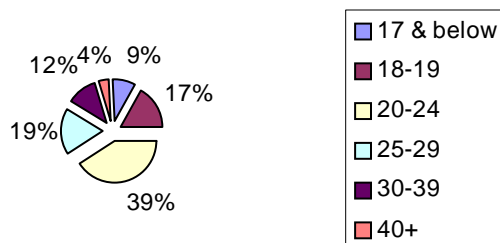
Nearly one in five women who use birth control received their first pill from Planned Parenthood.

Over 28,000 visits took place at PPWT's four health centers in 2007.

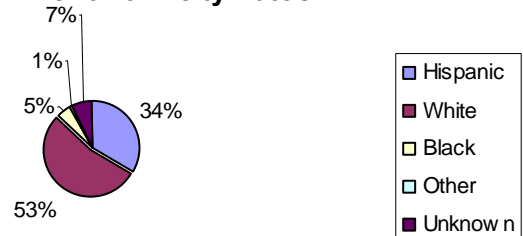
Over 14,571 Sexually Transmitted Infections (STI) tests were performed on male and females in 2007.

In December of 2007 all four **PPWT** health care centers distributed 400 emergency contraception kits free to the communities.
