A Message to Our Community

Dear friends,

Planned Parenthood is Here. No Matter What. You helped us keep that promise of care to our communities this past year through a series of challenges and opportunities.

We opened five new health centers and moved two more centers to larger facilities in the past two years to increase access to cancer screening, birth control and sexually transmitted infection testing and treatment services. When this urgently needed growth stretched our resources to the breaking point, supporters like you doubled the financial support to the affiliate. You are in good company! PPSP now enjoys the support of more than 10,000 donors for this past year alone!

When we opened our health center in Mendocino County — a county that had been without Planned Parenthood services for 18 years and one whose health department had just stopped offering family planning services, donors like you sent contributions to support that effort.

In the past two years PPSP hired and trained over a hundred new staff members for those new and expanded facilities to respond to the needs of the community. We have now also trained the new and existing staff to implement electronic health records in all but two of our 21 health centers. When these efforts — essential for expanding access and improving the quality of care — resulted in an expected first operating deficit this affiliate has experienced in 30 years, many of you increased your support and reduced that deficit by half.

When the Susan G. Komen Foundation tried to defund Planned Parenthood, your voices were heard across California and the nation. When we asked you to make calls and send emails to the State legislature in support of our Timely Access to Birth Control bill, you responded.

This coming year, we plan to rebuild our reserves and improve the efficiency of our operations. We will continue to provide the advocacy required to keep California a leader in the nation in providing access to preventive and reproductive health care. Our educators and case managers will fan out throughout our communities to help individuals make better reproductive health decisions. We will work with other safety net partners to insure that women's specific health needs will be met in the new health care systems created through the Affordable Care Act.

We know that we can only do this with your help. Together, we can meet the challenges ahead and create more positive outcomes for the men, women, and youth of northern California. Thank you for your support.

Planned Parenthood Shasta Pacific is here to increase the availability of accessible and affordable quality health care in our communities.

Last year we:

- Provided health care services to nearly 95,000 women, men and teens at our 21 health centers and nine additional limited services sites which is a 24% increase in two years.
- Opened a new health center in Ukiah, California within a month of Mendocino County’s public health clinic closure.
- Moved and expanded our Central Richmond health center to a 2800 square foot facility, close to the Richmond BART station.
- Laid 550 miles of new cable, installed 230 new computers and trained over 280 staff in electronic health records (EHR) systems over a 12 month period for enhanced health care.
- Offered Essure, a new hormone-free sterilization service for women.
- Earned full accreditation from the PPFA team that rigorously reviews each affiliate every three years to ensure that quality health care is provided at all Planned Parenthood health centers nationwide.
- Increased the size of our new Clearlake health center to provide a full-range of reproductive health care for the first time in decades. The 1500 square foot facility includes three exam rooms, two counseling rooms and a laboratory.



Planned Parenthood Shasta Pacific is here as a reliable source of sexual-health information and sound advice for teens, parents, and other adults.

Last year we:

- Provided sexuality education services to more than 40,500 youth, teens, parents and other adults.
- Coordinated Butte County’s first-ever Project Homeless Connect event and participated in San Francisco’s Project Homeless Connect for the first time, providing education, health center referrals, safer sex supplies and hygiene and menstrual kits to nearly 900 homeless people.
- Participated in San Francisco Pride 2012 by providing education at the Trans March, the Dyke March and the City’s two-day celebration at the San Francisco Civic Center. Over 100 PPSP staff, family, and friends marched in annual Pride Parade and won the “Absolutely Fabulous Theme Contingent,” awarded by the Sisters of Perpetual Indulgence.
- Provided a month-long sex education program for 54 high-risk youth at an alternative high school in Napa focusing on healthy relationships and behavioral risk reduction.
- Received the Planned Parenthood Federation of America’s 2012 Achievement in Diversity Award for our Disability and Sexuality Program.

Planned Parenthood Shasta Pacific is here to fight for access and funding for reproductive health, prevention, and education services.

Last year we:

- Maintained full funding for California’s family planning program during the ongoing state budget crisis.
- Passed four pieces of PPSP’s priority legislation that work to increase access to maternity services and preventive health care for young people. Combined, these bills ensure that all insurance plans in California cover maternity care, prohibit employers from refusing pregnancy and childbirth leave and allow teens to have access to preventive services including the HPV vaccine.
- Grew our vibrant online community of social networking and text supporters by nearly 200 percent.
- Engaged in live social networking at a variety of events, including a press conference with U.S. Representative Jackie Speier (D-CA) in San Francisco, Capitol Day in Sacramento, and World AIDS Day 2012.
- Launched a successful Voter Registration Drive, registering nearly 800 clients, staff, friends and family.
- Mobilized volunteers and supporters in phone banks to help defeat Mississippi’s dangerous Fetal Personhood Initiative which lost by a 2-1 margin.





Health Services Client Profile


Client Profile by Age

More than 90% of clients qualify for subsidized family planning services because their household incomes are less than 200% of the Federal Poverty Level (FPL). In 2012, the FPL poverty level for an individual is \$11,170 and for a family of 3 is \$19,090.
