

PPMET remains dedicated to providing youth with thorough, accurate information about their changing bodies and sexual relationships, even in a political climate of fear and denial regarding these issues.

Our professional educators in Nashville, Knoxville, and Chattanooga carry out this commitment through several programs:

- ▶ Reducing the Risk, a 5-10 session series that goes beyond the basics to equip teens with skills needed to make and carry out healthy decisions regarding sexual behavior (partly supported with CDC funds in Chattanooga and Nashville through the Tennessee Department of Health).

EDUCATION AND TRAINING



- ▶ PG-13 Players, PPMET's peer education theatre troupe that brings sexuality and other teen-related issues to life for young audiences (supported in part by the National Council of Jewish Women — Nashville Section and United Way of Metropolitan Nashville).
- ▶ Juvenile Detention Center Outreach, a collaboration with the Davidson County Juvenile Detention Center to teach young men and women information and skills regarding HIV and pregnancy prevention (partly supported with CDC funds).
- ▶ Short-term Education Sessions, delivered on request to middle and high schools, colleges, after-school programs, religious organizations, group homes, and other agencies that serve youth.
- ▶ Professional Training, for professionals who serve youth, building comfort and imparting skills to become effective sexuality educators in their own settings.
- ▶ Health Fairs and Outreach on college campuses, middle and high schools, and community events
- ▶ Family Life Educator of the Year Award, recognizes a sexuality educator who demonstrates particular sensitivity, skill, and creativity in their work with young people. Awarded annually.



MEDICAL SERVICES



Women, men and teens from across Tennessee made 9,844 visits for medical services from Planned Parenthood of Middle and East Tennessee during fiscal year 2005. Our services include:

- ▶ Birth Control Methods
- ▶ General Gynecological Care
- ▶ Emergency Contraception
- ▶ Sexually Transmitted Infection (STI) Testing and Treatment
- ▶ Pregnancy Testing and Counseling
- ▶ Counseling services
- ▶ Cancer Screening (breast, cervical, testicular and prostate)
- ▶ Abortion Services (Surgical and Medication)
- ▶ HIV/AIDS Testing and Counseling
- ▶ Colposcopy
- ▶ Primary Health Care
- ▶ Reproductive Health Education



DURING FISCAL YEAR 2005, PPMET PROVIDED:

- ▶ 3,927 family planning visits that included 609 pregnancy tests
- ▶ 1,520 annual gynecological exams
- ▶ 1,561 pap smears to screen for cervical cancer
- ▶ 2,599 tests and treatments for sexually transmitted infections (STIs)
- ▶ 310 HIV tests
- ▶ 622 primary care visits



ADVOCACY

LEGISLATIVE ACTIVITIES AND PUBLIC AFFAIRS

- ▶ Defeated SJR 127, a resolution to amend Tennessee's Constitution to remove privacy protections, including the right to seek an abortion.
- ▶ Introduced our first piece of pro-active legislation, the Emergency Care for Victims of Rape Act of 2005 or EC in the ER, which required emergency rooms to provide victims of rape with information about and access to emergency contraception (EC).
- ▶ Sent 10 action alert emails to our list of approximately 1,500 activists (a total of 10,220 emails!) alerting them about legislative activity. These messages resulted in 5,319 letters being sent to legislators regarding the protection of reproductive rights.
- ▶ Received a grant from the Centers for Disease Control to provide public education and awareness about the HIV Vaccine Trials Research Program at Vanderbilt University.
- ▶ Provided speakers for events sponsored by Medical Students for Choice at Vanderbilt University School of Medicine. We also assisted the group in hosting a fundraising reception held at Zeitgeist Gallery in Nashville.
- ▶ Sponsored VOX: Voices for Planned Parenthood chapters at Middle Tennessee State University in Murfreesboro, the University of Tennessee in Knoxville and Vanderbilt University in Nashville.
- ▶ Hosted a Live Action Camp to train 50 activists from five states.

THE J. PASCHALL DAVIS FUND

Established in 1992, the J. Paschall Davis Fund provides no-interest loans to assist poor and low-income women who would not otherwise be able to access abortion services. The Fund is named after the Reverend J. Paschall Davis, an Episcopal priest who was an early reproductive rights advocate in Nashville and the husband of one of the women instrumental in founding Planned Parenthood in Tennessee, Evelyn Ames Davis.

The Fund is supported entirely by individual donations, patient reimbursements, and grants from private foundations. No public funding can be used to support the Fund. No woman is ever turned away due to inability to pay.

In 2004-05, the Fund provided loans totaling \$13,013 to 39 women. The average loan was \$334, while the cost for an abortion was between \$500 and \$650.
