I'm proud that despite such a difficult year, we were able to keep all of our health centers open, serving patients with quality affordable care:





# HEALTH CARE AT PLANNED PARENTHOOD

each year at eleven health centers throughout Oregon and southwest Washington. We provide affordable, quality sexual and reproductive health care including life-saving cancer screenings, birth control, gynecological exams and Pap tests, prevention and treatment of STDs, HIV testing and counseling, HPV vaccinations, emergency contraception (EC), vasectomy, free pregnancy testing and options information, and early abortion care. Staffed by highly trained doctors, nurses, and other health care professionals, our doors are open to everyone.

- 95% of all patient visits to PPCW are for preventive sexual health care, including life-saving cancer screenings, birth control, prevention and treatment of STDs, gynecological exams, and health counseling.
- Less than 5% of PPCW services are for abortion care.
- 89% of our patients are low-income (below 200% of the Federal Poverty Level).

# PPCW //////////EDUCATION

PPCW's Education Department provides teens with comprehensive, medically accurate, age-appropriate sexual and reproductive health information.

Through our Teen Council and Teen Outreach Programs, PPCW partners with local schools and organizations to arm teens with the information they need to make smart, healthy decisions.

# **Teen Council**

Our Teen Council Peer Educators are trained by PPCW staff on comprehensive, evidence-based sexual and reproductive health information. Throughout the year, these teens do outreach at community events, teach their peers critical information through in-classroom curriculum, and host events to engage youth in learning more about sexual and reproductive health. The Teen Council program reached almost 15,000 middle and high school students last year.

# **Teen Outreach Program (TOP)**®

PPCW is excited to be offering the Wyman Teen Outreach Program (TOP) in Oregon. TOP is recommended by the U.S. Department of Health and Human Services' Office of Adolescent Health based on rigorous evaluation. The program uses an evidence-based positive youth development approach to prevent teen pregnancy by increasing teens' life skills in areas like healthy relationships, values, communication, decision-making, and sexual health equipping them with the tools they need to stay healthy and make good decisions.

During our first year with this new program, PPCW staff and educators around the state were trained and certified to facilitate the curriculum, and piloted the program with several groups. More than 800 high school students are now enrolled in one of PPCW's TOP groups.









PPCW partners with political organizations, Planned Parenthood Advocates of Oregon and Planned Parenthood Votes Washington for our public policy work. Some highlights from the past year include:

# **In Oregon**

- Helped block five pieces of anti-choice legislation, including a ban on abortions after 20 weeks.
- Passed bipartisan "Birth Control Matters" resolution in the Oregon legislature to urge the U.S. Department of Health and Human Services to include birth control coverage with no co-pays in the new health care reform plan.
- Introduced legislation and held hearings on a consumer protection bill to stop fraudulent crisis pregnancy centers from misleading women.
- Organized 150 activists from around Oregon who lobbied 84 legislators in Salem at Women's Health Care Day to advocate for birth control, sexual and reproductive health care, and women's reproductive rights.
- Recruited and mobilized more than 1,000 volunteers for three "Stand with Planned Parenthood" rallies around the state.
- Attended 28 festivals and fairs statewide, collecting almost 7,000 signatures while recruiting and activating more than 1,100 volunteers.

# In Washington

- Protected funding for family planning, even as the state cut budgets.
- Passed a bill in the Washington legislature requiring the state to ask for an expansion of the federal Medicaid waiver to include people up to 250% of the Federal Poverty Level.


