This donated vehicle consignment agreement (this "Agreement") is between \_\_\_\_\_

The Donor/Consignor hereby consigns the above-referenced vehicle (the "Vehicle") to the Consignee for the benefit of **Planned Parenthood Columbia Willamette**, and by so doing agrees to transfer possession of the Vehicle to the Consignee for sale as soon as reasonably possible (the "Sale").

This Agreement incorporates by reference the terms of that certain Agency Agreement between the Consignee and **Planned Parenthood Columbia Willamette**, (the "Donation Agreement") whereby the Consignee agrees to transport and sell the Vehicle for the benefit of **Planned Parenthood Columbia Willamette**. The parties acknowledge that **Planned Parenthood Columbia Willamette** is a third-party beneficiary of this Agreement.

**Fees/Costs:** The Donor/Consignor understands that a seller's fee of ten percent (10%) will be charged against the gross proceeds of the Sale, expenses and reasonable costs of Sale will be deducted from such proceeds, and all net proceeds of Sale will be paid to **Planned Parenthood Columbia Willamette**, in accordance with the terms of the Donation Agreement. Distribution of proceeds from the Sale will be issued by the Consignee within 10 days of sale to **Planned Parenthood Columbia Willamette**, who will then notify the Donor/Consignor of the sale amount.

**Donor/Consignor's Representations, Warranties, and Covenants:** The Donor/Consignor represents, warrants, and covenants:

1. The Vehicle is in good working order except as noted in the attached: (*check one*)

2. The Donor/Consignor is either (1) the registered owner of the Vehicle, (2) a certified dealer, (3) a lessor, or (4) a security interest holder (who has completed a repossession action of the Vehicle) who has the right to sell the Vehicle;
