I give permission to Planned Parenthood to make and to receive from the Minor and third parties, photos and video and audio recordings and any other recordings and transcriptions that include my name, voice, likeness, and statements (together called "Content").

I represent and warrant that any Content that the Minor provides to Planned Parenthood is his/her own original work, and is not subject to any rights of any other parties. Parent and Minor indemnify and hold Planned Parenthood harmless from any claims, actions, damages, or liabilities arising out of the breach of this representation and warranty.

I grant to Planned Parenthood the absolute and irrevocable right to use, publish, reproduce, distribute, and display the Content (in whole or in part) in perpetuity, in any publication or media (whether online, off-line, now known, or invented in the future) for any purpose relating to Planned Parenthood's mission, including but not limited to advertising, promotion, and trade purposes that promote Planned Parenthood's mission. This means, for instance, Planned Parenthood can broadcast video and audio podcasts of the whole recording or parts of it on Planned Parenthood websites, other websites (such as YouTube.com), or television and radio. I also grant Planned Parenthood the right to edit or make derivative works from the Content. I understand I will not have notice or the opportunity to review or approve these uses, which are strictly within the discretion of Planned Parenthood.
