Dear Friends,

We know this edition of *News Source* might find you feeling outraged, as we are, at the threats to reproductive freedom happening across our country right now.

Texas passed the most restrictive abortion ban in over 50 years, which also isolates those seeking abortion by targeting their entire support network and discouraging their loved ones from helping them for fear of being sued. Unfortunately, this is just the beginning. With the new conservative Supreme Court deciding to take up *Dobbs v. Jackson Women's Health Organization*, we anticipate *Roe v. Wade* will be dismantled. We see a frightening future where as many as 26 states across the country could ban abortion.

People seeking abortion care in states with limited or no access face significant financial, travel, and logistical hurdles. This disproportionately impacts people with low incomes, people in rural areas, and marginalized communities who already face immense barriers to health care access.

Meanwhile, right here in New Hampshire, we've seen how just one election can turn the tide – where for the first time in over 200 years, NH passed a cruel abortion ban at 24 weeks. This ban has no exception for rape, incest, or fatal fetal diagnosis, and requires medically unnecessary and costly testing for all abortion care. And then just a few

weeks ago, the NH Executive Council defunded PPNNE – stripping funds that helped subsidize life-changing, life-saving care for low-income Granite Staters.

We were certainly relieved to get the recent news that the Biden-Harris administration ended the Title X gag rule, which had forced PPNNE to withdraw from the Title X program. Title X funding may resume as soon as March or April 2022, though an exact date is not yet known.

While we celebrate this news, we know it doesn't mark the end of attacks aimed at sexual and reproductive health care in the U.S. and here in northern New England.

We are committed to doing all we can to mitigate the harm. We are all responsible for making sure patients seeking abortion care have access, regardless of zip code or economic means. We are in this together, all the way.

As you'll see in the following pages, our resolve has never been stronger. We know we have an important role to play in helping provide access to care. This will be a state-by-state effort and we need to be as strong as possible here in Maine, New Hampshire, and Vermont – and **together with you, we can be.**

# The Current State of **Reproductive Freedom**

**Texas** On September 1st, a new Texas law went into effect that bans all abortions at 6 weeks of pregnancy – before most people even know they're pregnant. Known as S.B. 8, this law also allows people across the country to sue anyone who helps someone get an abortion after six weeks in Texas, and collect a \$10,000 minimum reward for each successful lawsuit. On October 6th, the U.S. Dept of Justice was granted a preliminary injunction which restored the right to abortion for millions of Texans, but an immediate appeal stayed the injunction, meaning S.B. 8 is back in effect as we go to print. **We know this fight is far from over, and that this harmful legislation won't stop here;** it's part of a national agenda to end access to abortion in this country.

**U.S. Supreme Court (SCOTUS)** When SCOTUS had the chance to step in and block S.B. 8, they chose not to take action. Additionally, they recently announced they will take up a case regarding Mississippi's 15-week abortion ban, *Dobbs v. Jackson Women's Health Organization* in December. The case could render *Roe v. Wade* meaningless and would leave abortion access up to each state. Current projections show as many as **26 states could ban abortion.**

**New Hampshire** Earlier this year, New Hampshire passed a **24-week abortion ban**, which will take effect in January of 2022. The law has no exceptions for rape, incest, or a fatal fetal diagnosis, and includes mandated

medically unnecessary ultrasounds. And just a few weeks ago, **the NH Executive Council voted 4 - 1 to deny PPNNE's family planning contract.** Between earlier drastic state budget cuts and the Executive Council's defund vote, PPNNE is facing a nearly \$1 million loss in funding this fiscal year.

**What We're Doing** We are committed to ensuring every patient seeking abortion care can access it, regardless of their zip code or economic means. What this looks like:

- Ensuring that Advanced Practice Clinicians, not just MDs, in our states can provide abortions.
- Expanding the days and times abortion care is available.
- Preparing to serve patients from Texas and other states where access is eroded.

**Being Pro-active** We're in the final year of working to pass the Reproductive Liberty Amendment (RLA) to the Vermont State Constitution. If *Roe v. Wade* is dismantled, the RLA would protect every Vermonter's right to make their own reproductive decisions, including whether and when to become a parent, use temporary or permanent birth control, or seek abortion care. **Vermont would be the first state in the nation to enshrine these rights in their constitution.** The next step in the process is a vote by the VT House in the 2022 Legislative session. If passed, the RLA will be a 2022 General Election ballot measure, decided by Vermont voters.


It didn't take long to see the effects of the Texas 6 week ban on abortion, even here at PPNNE. The day after the ban went into effect, our call center fielded a call from a patient in Texas, looking for abortion care. They came to us about a week later:

"She found out she was pregnant on September 1st, the day the ban started in Texas, and she and her partner told me that at first, **they didn't know what to do or who to call**.

After her procedure, her partner told me that they had initially scheduled in NYC, then he called our affiliate and spoke with someone in the call center. They were both incredibly grateful for the care they received." **Here's what they had to say about their experience:**



*"When I talked to your organization, you told us, just show up, we'll find funding if you need it, we'll make sure you're taken care of... and I could tell that they meant it, that we really would be taken care of."*
