LETTER FROM PRESIDENT & CEO MEAGAN GALLAGHER

Dear Friends,

In February, we sent you a special edition of this newsletter to update you on the Title X Gag Rule – an effort to block Planned Parenthood’s participation in the Title X federal family planning program. Despite exhausting every option available to stop the government from interfering with a patient’s relationship with their provider, **the Gag Rule is now in effect and PPNNE has been defunded.** It is chilling to see how far the Trump administration will go to prevent people from accessing reproductive health care.

PPNNE has made a commitment to our patients that the loss of this funding will not affect their ability to access our care, regardless of race, gender identity, sexual orientation, income, zip code, or immigration status.

Our doors remain open and no one is turned away because of an inability to pay.

Inside this edition of *News Source*, you’ll learn more about the defunding and about a wonderful opportunity to have your financial support go even further at this time.

A QUICK REFRESHER

What is Title X?

Title X (pronounced Title Ten), established in 1970, is the nation's program for affordable birth control and reproductive health care. Receiving \$1.8M annually, PPNNE had participated in the Title X program since it started 50 years ago, allowing patients to receive affordable birth control, wellness exams, cancer screenings, and STD testing and treatment.

What is the Gag Rule?

On February 22, 2019, the Trump-Pence Administration finalized changes to Title X that required Title X providers to withhold information about abortion to patients. This rule is a clear violation of medical ethics and standards of care.

How Title X Serves Our Region

Last year, **more than 31,000 patients** were served at PPNNE's 21 health centers across Maine, New Hampshire, and Vermont through the Title X program.



11,557 of our New Hampshire patients were served through Title X.



10,106 of our Maine patients were served through Title X.



9,772 of our Vermont patients were served through Title X.

Title X patients make up 76% of the total number of patients we serve.

PPNNE FORCED TO WITHDRAW FROM TITLE X

On August 19, PPNNE, along with all other Planned Parenthood affiliates across the country, were forced to withdraw from Title X because the unethical Gag Rule would have prevented us from giving our patients complete and accurate information.

PPNNE's health care providers are not going to conceal any information from our patients in exchange for federal funding, and we refuse to let the Trump administration bully us into withholding information about safe, legal abortion.

PPNNE has made a commitment to our patients that the loss of this funding will not affect their care. All PPNNE health centers across Maine, New Hampshire and Vermont remain open and no one is turned away because of an inability to pay.

We are able to keep this promise to patients because of careful planning by PPNNE staff,

backfill funds, and of course, generous support from donors which plays a crucial part in our ability to serve all those who come to us, each and every year.

We are incredibly grateful to our state legislature and Governor in Vermont, and to legislative leadership in New Hampshire for providing state funds to cover the loss of federal funds. In Maine, Speaker of the House, Sara Gideon, has introduced a bill to restore funding in 2020.

This is the groundwork we've been laying for years in our region, knowing this threat was imminent. Your voices and support are what make this possible. However, with rising health care costs and never-ending battles to protect patient access, **we still have to raise more this year than we've ever needed to in annual support.** There is no better time to stand with PPNNE patients.
