



In 2016, Planned Parenthood Federation of America celebrated century of care, education, and activism that has changed everything about the way we live and love. Our progress has been hard fought. Since the day in 1916 that three women were arrested at a small storefront in Brooklyn – just for handing out information about how to prevent pregnancy – Planned Parenthood’s mission has faced opposition. Even though those attacks have reached a fever pitch, I am pleased to report to you our successes.

Every day, our doctors, clinicians, and staff open the doors of Planned Parenthood of Maryland (PPM) health centers to provide high-quality, compassionate care. In 2016, PPM was named a Leader in LGBT Healthcare Equality by the Human Rights Campaign Foundation. We expanded our online appointment scheduling to include abortion services. Maryland was at the forefront of the fight for reproductive justice in 2016 when the Contraceptive Equity Act was passed, requiring insurance companies to cover over-the-counter emergency contraceptives and eliminating most co-pays for birth control. Additionally, PPM expanded our prevention services by adding PrEP, a daily regimen to prevent HIV.

Included in this report is data that represents the scope of our work and the services that we offered in 2016. But behind these figures are incredible human stories, stories from patients and staff, from our donors and volunteers. When we talk about our successes and the battles we face, we must never forget the impact that we have on individuals, and the transformative effect that Planned Parenthood has on our community and the 40,000 patients that we serve.


We have worked for this progress for nearly 90 years in Maryland. Planned Parenthood isn’t the problem – we are the solution. And Planned Parenthood will continue providing care to everyone who comes through our doors. No matter what.

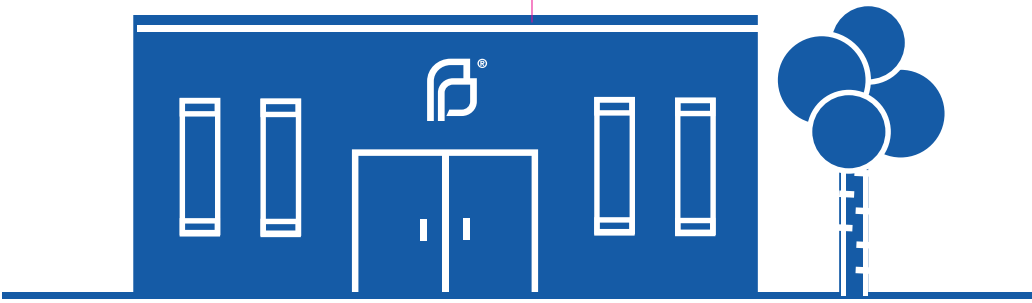
